Active Clients: Clients who have received services by Theresa M Cukierski, LPCC-S between October 30, 2017-December 15, 2017.

Inactive Clients: Clients who have NOT received services since October 30, 2017, and have NOT specifically coordinated their continuation of care with Theresa in advance **are ineligible to resume services at Theresa M. Cukierski, LLC until after March 19, 2018.**

Theresa M Cukierski, LLC is committed to providing quality and ethical care to meet the therapeutic needs of each client. Continuation of Care with the Interim Therapist is to support the care and therapeutic approach active clients are currently receiving at Theresa M Cukierski, LLC. The objective is to maintain, or improve, the current functioning of active clients until Theresa returns from Full Maternity Leave. **Active Clients who have a more severe need for treatment may begin to be seen by Theresa beginning March 5, 2018. This is to be coordinated with the Interim Therapist.** Theresa will periodically check her voicemail/email and will return messages as soon as possible. However, this should not be used for primary care and immediate needs during maternity leave. **If you believe you have a higher need of care than what can be provided during this time, PLEASE DO NOT HESITATE to contact another local resource that may be able to more thoroughly address your therapeutic needs.
